



#### **Director's Message:**

I'd like to let you know about an important upcoming question on the general election ballot on November 7th.

The Library Construction Bond Referendum should be of great interest to libraries and the communities they serve here in New Jersey. If NJ voters approve the Library Construction Bond Act, the state will issue \$125 million in bonds, the proceeds of which will provide 50% of the funding for public libraries' construction and renovation projects. The balance of the funding would come from local or private sources.

Here are some important details:

- The bill has bipartisan support in both the State Assembly and State Senate.
- Interested libraries would apply for these funds through the State Librarian, in consultation with Thomas Edison State University, who will establish eligibility criteria for the receipt of grants.
- The state will repay the bonds out of state revenues, not through local property taxes.

Eighteen years have passed since the last Construction Bond Act was approved. At that time, sixty-eight communities were able to build or renovate their facilities. Since then, libraries have continued providing extensive services to patrons -- despite budget cutbacks -- in outdated and insufficient facilities, and in times of great need. The recent recession put an additional strain on library buildings, furnishings, and resources that were already outdated. Many New Jersey libraries are still not ADA-compliant, which means that some people have great difficulty accessing the library and its resources, or are not able to do so. Other library buildings require substantial renovations to fix major problems such as leaky roofs and basements. Technology upgrades are also necessary in most libraries, as the needs of the community surpass the older infrastructure. If approved, the construction funds would help libraries increase their safety and accessibility, provide communities with enhanced state-of-the-art facilities, and create opportunities to invest in the NJ workforce through construction jobs.
